

Test Requested: PHOX2B repeats

Test	The <i>PHOX2B</i> gene was sequenced to investigate for the presence of common polyalanine repeat expansion mutation PARM (heterozygous in-frame duplication within the 20 alanine stretch of the <i>PHOX2B</i> Protein) which could be the mutation causing Congenital central hypoventilation syndrome in the affected child.
